On behalf of Saratoga Biochar Solutions, LLC (SBS), Sterling Environmental Engineering, P.C. (STERLING) submits this report of enhanced public participation activities performed for the subject project to comply with New York State Department of Environmental Conservation (NYSDEC) Commissioner Policy 29 (CP-29). Enhanced public participation was performed in accordance with the Public Participation Plan dated December 1, 2022 and revised March 14, 2023, as approved by the NYSDEC Office of Environmental Justice.

#### **Document Repository**

Permit application documents are maintained electronically on a dedicated document repository website for direct download (<a href="www.saratogabiochar.com/PPP">www.saratogabiochar.com/PPP</a>). A physical document repository is available at the Hudson Falls public library.

#### **Public Outreach and Notice**

A public meeting was held on December 19, 2022, as summarized in the December 29, 2022 Progress Report submitted to NYSDEC. Recommendations following the December 19, 2022 meeting included holding an additional meeting to allow in-person participation. Two additional meetings were held on March 28, 2023 and March 29, 2023 at the Sandy Hills Art Center located at 214 Main Street, Hudson Falls, New York. The March 28, 2023 meeting was scheduled from 6 to 9 PM, and the March 29, 2023 meeting was scheduled from 2 to 5 PM. Both meetings ran over the allotted time to allow all participants to have a chance to speak and were live streamed via Zoom to allow for remote participation. In advance of the meetings, targeted public outreach was made to ensure identified stakeholders were made aware of "Serving our clients and the environment since 1993"

the project, the dates of public meetings, and how to submit questions and/or comments. The following targeted outreach was performed:

- 1. Direct mailings were made to the contact list contained in Appendix B of the March 14, 2023 Public Participation Plan. The mailings included the Project Fact Sheet and Public Meeting Notice. Notices were also submitted by email to contacts with email addresses. The mailings specifically targeted residents within the Potential Environmental Justice Areas and/or Disadvantaged Communities of Glens Falls, Hudson Falls, and Fort Edward within two miles of the project location. Mailings were also made to Town of Moreau residents within 0.5 miles of the facility. A total of 4,296 discrete mailings were made with 300 (7%) mailings returned as undeliverable. The primary reason for returned mailings was due to the property being vacant. Proof of mailing is included in Attachment 1.
- 2. Newspaper Notices of the public meeting were published in the Times Union on March 14, 2023 and the Post Star on March 15, 2023. Note that the Post Start inadvertently published an incorrect meeting location on March 13, 2023, and subsequently published a correction on March 20, 2023. Copies of the proof of publication are included in Attachment 2.

#### March 28, 2023 Public Participation Meeting

The public meeting began at 6:08 PM with an introduction, followed by a 30-minute presentation by SBS, and then opened to the public for questions and comments. The meeting extended beyond the scheduled ending time and concluded at 9:30 PM. There were 64 recorded in-person attendees as summarized in the following table. A copy of the meeting sign-in sheet is included in Attachment 3.

As shown in the table, the meeting achieved the objective of reaching community members outside of the Town of Moreau. In addition to in-person attendance, approximately 74 attendees (at peak attendance) participated remotely via Zoom. A copy of the remote participant list is included in Attachment 3. Note that duplicate names in the participant list are excluded from the attendance count since these duplicates likely represent the same participant logging in more than once.

Questions and comments were received from both the in-person and remote participants throughout the duration of the question and comment period. The meeting went smoothly and extended beyond the scheduled ending time to allow everyone wishing to speak to have an opportunity. The recording of the meeting and participant list are posted on the document repository website.

#### March 29, 2023 Public Participation Meeting

The public meeting began at 2:00 PM with an introduction, followed by a 30-minute presentation by SBS, and then opened to the public for questions and comments. The meeting extended beyond the scheduled ending time and concluded at 5:45 PM. There were 20 recorded in-person attendees as summarized in the following table. A copy of the meeting sign-in sheet is included in Attachment 4.

As shown in the table, the meeting achieved the objective of reaching community members outside of the Town of Moreau. In addition to in-person attendance, approximately 71 attendees participated remotely via Zoom. A copy of the remote participant list is included in Attachment 4. Note that duplicate names in the participant list are excluded from the attendance count since these duplicates likely represent the same participant logging in more than once.

Questions and comments were received from both the in-person and remote participants throughout the duration of the question and comment period. The meeting went smoothly and extended beyond the scheduled ending time to allow everyone wishing to speak to have an opportunity. The recording of the meeting and participant list are posted on the document repository.

#### **Summary of Comments**

Questions and comments were responded to in real time during meetings. A summary of the questions and comments is provided below. Similar comments have been grouped together and are summarized by topic. The questions and comments received were similar to topics raised during December 19, 2022 public meeting and during the local Site Plan review process and completion of the State Environmental Quality Review by the Town of Moreau Planning Board as Lead Agency. Repeated comments that are summarized in the December 29, 2022 Progress Report are not restated below.

Permitting Process

Comment 1: How does proximity to potential EJ areas and DACs impact the permit review?

Response: The proximity to potential EJ areas and DACs requires enhanced public participation and expands the review of potential adverse environmental impacts from the immediate vicinity of the project to those identified communities. Enhanced public participation is performed to ensure opportunities for public involvement from these communities. The expanded review is performed to ensure these communities do not bear a disproportionate burden of environmental impacts.

Comment 2: Will there be closure funds?

<u>Response</u>: NYSDEC regulations require the facility to maintain financial assurance in an amount sufficient to cover the closure costs. The financial assurance must be in place before the facility can initiate operations and must be maintained for the life of the facility with regular adjustments to account for inflation.

Facility Traffic

<u>Comment 1</u>: Will trucks travel through downtown Hudson Falls and Fort Edward if coming from the northeast?

<u>Response</u>: A representative from Casella Organics was present at the meetings and confirmed that trucks will adhere to the established truck route. Trucks originating from the northeast will travel west on Route 149 to Interstate 87 and Exit 17 to follow the truck route. Trucks will not travel through downtown Hudson Falls or Fort Edward.

Comment 2: Will trucks come from New York City and Long Island?

Response: A representative from Casella Organics was present at the meetings and confirmed that Casella currently has no contracts to manage biosolids from New York City. During the March 29, 2023 meeting, SBS executives confirmed that the facility would not receive biosolids from New York City.

<u>Comment 3</u>: Concern that the Town-designated truck route to the Moreau Industrial Park cannot accommodate the volume of truck traffic for the SBS facility and that a new traffic study should have been conducted.

Response: Several commenters expressed concern over the Town-designated truck route. One series of comments focused on potential noise and odor from trucks passing their residences and suggested that the truck route should follow a more direct route north on Route 9 and east on Bluebird Road. SBS explained that the truck route was designated by the Town of Moreau and the truck route was extensively discussed during the Planning Board Review. The suggested truck route cannot be used due to local truck length and weight restrictions on Bluebird Road and proximity to Moreau Elementary School.

A second series of comments focused on the validity of the traffic study contained in the Generic Environmental Impact Statement (GEIS) for the Moreau Industrial Park. Commenters stated that the industrial park would not be able to accommodate the peak hourly traffic represented in the traffic study. One commenter with a 40-year career experience in the trucking and logistics industry spoke at length on this topic during the March 29, 2023 meeting. The commenter stated that the truck route should be able to accommodate the SBS traffic of 50 trucks per day with no issues. The commenter's concern was with continued future buildout of the industrial park. SBS agrees that the projected facility traffic can be accommodated by the traffic route and respectfully directs citizens with concerns over future buildout of the industrial park to make their comments to the Town of Moreau Planning Board for consideration during review of future applications.

Manufactured Carbon Fertilizer

Comment 1: Does the New York State Fertilizer Phosphorus Law apply to Carbon Fertilizer<sup>TM</sup>?

Response: The New York State Fertilizer Phosphorus Law applies to the use of lawn fertilizers. The manufactured Carbon Fertilizer<sup>TM</sup> is intended to be used as a soil amendment primarily in agricultural and garden use. An application for a Beneficial Use Determination has been submitted to the NYSDEC that outlines the intended use of the Carbon Fertilizer<sup>TM</sup> and includes an example product label. SBS intends to license the Carbon Fertilizer<sup>TM</sup> as a commercial fertilizer in New York State. The marketing, distribution, and sale of manufactured Carbon Fertilizer<sup>TM</sup> will be in accordance with applicable laws and regulations. A statement summarizing this response was made by SBS executives during the March 29, 2023 meeting.

<u>Comment 2</u>: Is the Carbon Fertilizer<sup>™</sup> like Milorganite? Will the Carbon Fertilizer<sup>™</sup> smell?

Response: Carbon Fertilizer<sup>TM</sup> is an entirely different product than Milorganite. Milorganite is heat-dried biosolids that contains organic matter that can generate an odor when the material becomes wet. Carbon Fertilizer<sup>TM</sup> goes through an additional step after heat drying (i.e., pyrolysis), which removes all volatile compounds from the solid Carbon Fertilizer<sup>TM</sup>. Therefore, there is no odor to Carbon Fertilizer<sup>TM</sup> when the material is dry or wet.

Concerns Regarding Per- and Poly- Fluoroalkyl Substances (PFAS) Compounds

Comment 1: Concern that there is no test method for PFAS compounds in air.

<u>Response</u>: There are current test methods for determining concentrations of specific PFAS compounds in air. Test Method EPA OTM-45 is used for stack emission testing. Testing procedures must be provided to NYSDEC in advance of sample collection for approval.

Comment 2: Who will be doing compliance air monitoring?

<u>Response</u>: Compliance air monitoring will be performed by qualified personnel who may be facility employees or a subcontractor. Advance notice must be provided to NYSDEC for all stack tests to allow NYSDEC personnel the opportunity to observe. Certified independent laboratory results will be made publicly available on the SBS website along with all required submittals to regulating authorities.

Comment 3: How often will air monitoring be performed?

<u>Response</u>: Stack testing will be performed as required by the NYSDEC permit. SBS indicated that they are willing to meet with community members to discuss the monitoring frequency if and when the permit is issued. SBS may perform more testing than is required in the permit and is committed to making the monitoring data publicly available on the SBS website.

Comment 4: How do you know where PFAS goes in this process?

Response: Scientific literature and SBS's own bench scale data support the understanding that PFAS compounds are removed from biosolids during the pyrolysis process and enter the gas phase. Once in the gas phase, the PFAS compounds are more vulnerable to destruction in the thermal oxidizer. The thermal oxidizer designer and manufacturer, Process Combustion Corporation, has reviewed the SBS bench scale data to specify minimum operating temperature and residence time to destroy PFAS compounds.

Concerns with Importing Biosolids

<u>Comment 1</u>: The Upper Hudson Region has a history of pollution and should not be a dumping ground for waste materials.

<u>Response</u>: SBS acknowledges the public sensitivity to the history of the Upper Hudson Region, and specifically the legacy of PCB contamination by GE. SBS is proposing to construct a state-of-the-art facility with environmental stewardship at the forefront of the design. SBS will maintain an open dialogue with concerned citizens to provide access to information and answer questions. SBS rejects analogies between SBS and its pyrolysis process to manage non-hazardous biosolids and the region's history of pollution from large-scale use of hazardous compounds, such as PCBs.

#### **Discussion**

As indicated in this report, the stakeholders identified in the Public Participation Plan were provided the opportunity to become familiar with the project, ask questions, and submit comments. The additional public meetings have achieved the objective of providing in-person opportunities for public engagement, which was a primary recommendation following the initial public meeting that was only held virtually on December 19, 2022. The topics of questions and comments were similar to topics raised during the December 19, 2022 public meeting and during the local Site Plan review process and completion of the State Environmental Quality Review by the Town of Moreau Planning Board as Lead Agency.

There continues to be targeted opposition against the project solely for the reason of pursuing the Moreau Industrial Park. A March 29, 2023 article in the Post Star (copy provided in Attachment 5) summarizes this public sentiment with the article title of "We just don't need it here: Residents appreciate Saratoga Biochar dialogue, remain wary." The article supports the effectiveness of the public participation meetings indicating that attendees appreciated the meetings and some now believed the project "might not be as bad as they initially thought." Nevertheless, opposition remains based entirely on location. As summarized in the article, one opponent stated, "I understand that it has to go somewhere. I think it's a wonderful concept if you guys can make this work – Hats off, because we need it. We just don't need it here."

The Final Scoping Plan for achieving the goals of the Climate Leadership and Community Protection Act (CLCPA) provides a strategy for the management of biosolids. Key among the recommendations is to reduce landfill disposal and support beneficial use. To achieve this goal, new facilities are required to manage the volume of biosolids diverted from landfills. SBS contacted the Saratoga Economic Development Corporation and was directed to look at the Moreau Industrial Park. The location was selected due to having appropriate zoning, appropriate utilities, was available for sale, has good truck access from Interstate 87, and works with SBS's contracted feedstock hauler.

#### Recommendations

SBS has implemented the approved Public Participation Plan to promote the fair involvement of all people in the NYSDEC environmental permit process, consistent with CP-29. Implementation of the Public Participation Plan has opened avenues of dialogue between SBS and the public. Therefore, ongoing communication is recommended to occur directly between SBS and community members as questions arise. Documents will continue to be added to the document repositories up to and including draft permits from NYSDEC when issued. No additional public meetings are recommended at this time.

# 'We just don't need it here': Residents appreciate Saratoga Biochar dialogue, remain wary

HUDSON FALLS — The energy inside the Sandy Hill Arts Center meeting room on Wednesday afternoon differed slightly from the Tuesday night meeting in the same space with the same presentation from the men behind the proposed Saratoga Biochar Solutions facility.

Local community members gathered again to voice concerns about the project now before the state Department of Environmental Conservation, but this time even those against it, thanked the panel for holding the meetings.

The company is required by the state DEC to hold public participation meetings in order to complete its applications for air and solid waste permits. Bryce Meeker, president of Northeastern Biochar Solutions and Saratoga Biochar Solutions, Chief Operating Officer Lee Wulfekuhle, CEO Raymond Apy and Andrew Millspaugh, a hired engineer for the project, spoke to the locals during two, three-hour meetings. Patrick Ellis from Casella Waste Management was also in the audience for both meetings to answer questions about transporting and origin of the biosolids.

Tom Masso spoke at the Tuesday meeting citing many of *The Post-Star* articles written in conjunction with the Lee Enterprises Community Services Journalism team about the project. He spoke again on Wednesday, but began by thanking the men.

Several meeting attendees even said the company swayed them to believe the project might not be as bad as they initially thought, but they still say "not Moreau."

"Moreau is not the guinea pig; we have to start somewhere. We want to roll this out across the nation, but we have to get it started so others can see it as well. We are not here to harm. We are here to help," Meeker reassured the small crowd gathered on Wednesday.

Despite the smaller turnout at the second day meeting — with 70 in the room on Tuesday and 50 online at the peak— and some familiar faces that have opposed the project since its proposal returning, the dialogue in the room was lighter at times. Therese Gillis, of Hands of the Hudson, even suggested Meeker run for president, as he "tries very hard to always find an answer."

However, she was not only there to suggest the next big move for the president of the company. Near the end of the meeting, which ran 30 minutes past its scheduled end, she stepped up to the microphone several times.

"There are a lot of passionate people involved in this, yourself included Bryce, and sometimes it gets long-winded, but we're all passionate and that's what brings us here," Gillis began. "A lot of us in attendance last night stayed up until the wee hours of the night researching. We didn't sleep all night, but maybe if we can get you to consider these things, it wasn't for nothing."

Gilles spoke after Cynthia Roberts, a young Hudson Falls mom, expressed her concerns about what the emissions could possibly mean down the line for her children.

"I'm from Fort Edward. I was born here and I stayed here, and I really think you will be long gone in 30 years. I would be about 97, but my grandchildren live just two blocks from me and that's our concern. Your kids aren't here," Gillis said. "We've already withstood enough in this region so, I understand that it has to go somewhere. I think it's a wonderful concept if you guys can make this work — hats off, because we need it. We just don't need it here."

Tracy Frisch, a key figure behind the Article 78 lawsuit filed against the Moreau Planning Board and Saratoga Biochar Solutions that is currently being heard by a judge in state Supreme Court of Saratoga County, even found some common ground with the company regarding removing PFAs from food-grade plastics.

The man who lives closest to the the proposed site, George Padron, also thanked the Biochar executives for the continued dialogue and opening the meeting up for inperson attendance, but he still voiced his concerns about the continuous monitoring of stack emissions the company agreed to.

Not all who climbed to the fifth floor of the Sandy Hill Arts Center were opposed to the project. Brigid Martin, Moreau's town historian and South Glens Falls resident, excitedly asked "when will you be open?" when her time came to speak. Martin was originally commenting via Zoom, but joined the meeting in person for the last hour.

She accused many of the project's critics of lying and raved about the "cutting-edge technology" Saratoga Biochar Solutions promises to demonstrate and the jobs the facility will bring to Moreau, which Apy said would be only about 12 to 13 at first. The company has already received employment inquiries.

"The industrial park is an investment that the town of Moreau has been making for a number of years and it's been left vacant, so I appreciate you people coming to the town with cutting-edge technology that's gonna clean up the environment," Martin said at the meeting. "I apologize for the way you've been treated in our town and by people that don't live in our town."

Former Moreau Town Supervisor Harry Gutheil also spoke about his concerns with the decisions surrounding the proposal.

"I'm disappointed and I think the Planning Board was misguided on the advice they got not to hire a third-party consultant. I don't think anybody here realizes the complexity of this situation and I wouldn't expect the volunteer members of the Planning Board to have the expertise to do all this on their own. They put themselves in a position to make their decisions very dependent on DEC, and at DEC, the air quality divisions are generally underfunded and understaffed so, when it comes to monitoring, shutting someone down and getting a quick response, I can almost bet money it won't be there," Gutheil said. "I'm gonna leave here with even more concerns than when I came."
