Your application for Permit is incomplete. The following items are required:

Air State Facility items: Please provide the following information in support of your Air State Facility application:

1. Estimated manufacturer PFAS compound destruction efficiency for the thermal oxidizer.
2. AERMOD results for PFAS compounds using PFOA as a surrogate and aggregating for all compounds.
3. Estimate of incoming biosolids PFAS concentrations and an estimate of total PFAS compounds emissions from facility.
4. Overlay the final Disadvantaged Community (DAC) areas on the AERMOD maps, use the shapefiles available on DEC's website;
5. Revise the CLCPA analysis to include indirect emissions associated with truck traffic to and from the facility. Emission factors in EPA's GHG Emission Factors Hub (https://www.epa.gov/system/files/documents/2023-03/ghg_emission_factors_hub.pdf) can be used for this purpose.
6. Resubmit a revised CLCPA both Section 7(2) and 7(3) analyses for the entire facility as a single document/report that captures all of the changes/revisions requested and provided to DEC.
7. Resubmit a complete Air State Facility application incorporating all design changes.

Solid Waste Management items: Please provide the following information in support of your Solid Waste application:

1. Regarding your 4/4/22 response to DEC comment #2: Is additional storage necessary for incoming material? What if the facility goes down for a day and incoming biosolids cannot be processed that day?

2. Regarding your 4/4/22 response to DEC comment #3: Is additional storage necessary for finished product? Does this storage provide sufficient capacity in the event you're unable to move product?
3. In the BUD petition it states that during the startup period, manufactured product will be sent to a regional compost facility. What facility is this and are they authorized to accept this material?
4. In the BUD petition it states that 25% of biosolids in NY are going out of state. Please provide a source for this percentage.
5. For the guaranteed analysis/carbon fertilizer value in the BUD petition, please include test data or sources for this information.


